**ORDER**

This Court on 27.09.2022 passed following order:

“At the request of the learned counsel for the appellant, three weeks time was granted to comply with the office objections on 6.9.2022. There is no compliance. There was no representation for the appellant in the morning as well as in the afternoon. In the interest of justice, further two weeks time is granted to comply with the office objections, subject to payment of costs of Rs.3,000/- to the Advocates Association Library Fund, High Court of Karnataka, Dharwad Bench, Dharwad.”

Thereafter, on 05.01.2024 passed the following order:

“No representation for the cross objector in the morning as well as in the afternoon.

This Court by order dated 27.09.2022 granted two weeks time to comply office objections on payment of cost of Rs.3,000/- to the Advocates Association Library Fund, High Court of Karnataka, Dharwad Bench, Dharwad. Neither office objections are complied nor cost is paid till this date.



Finally two weeks granted to comply office objections and to pay cost.

2. Today also there is no representation for the cross-objector and office objections are not complied or cost as directed is paid. It appears that the cross-objector is not interested in prosecuting the cross-objection. Hence, the cross-objection is dismissed for non-prosecution.
