"MEMO FOR WITHDRAWAL

The Counsel for the Petitioners respectfully submit as follows:

The present writ petition was filed challenging the survey notice/proceedings initiated pursuant to the final decree passed in FDP No.61/2021.

During the pendency of the writ petition, the survey proceedings have been completed, survey report has been submitted and acted upon and consequential revenue entries have also been effected in the revenue records.

The cause of action on which the present writ petition was instituted no longer survives for consideration by this Hon'ble Court.

In view of the subsequent developments, the present writ petition has become infructuous.
