DISTRICT AND SESSION JUDGE UTTARA KANNADA, KARWAR AND C.C.NO. 47/2008 ON THE FILE JMFC (II-COURT) KARWAR AND SET ASIDE THE IMPUGNED JUDGMENT DATED 07.07.2022 PASSED BY THE PRL. DISTRICT AND SESSION JUDGE UTTARA KANNADA, KARWAR, IN CRIMINAL APPEAL NO. 51/2014 CONFIRMING THE ORDER PASSED IN C.C.NO. 47/2008 DATED 01.04.2014 PASSED BY THE JMFC (II-COURT) KARWAR WHEREBY CONVICTING THE PETITIONER FOR OFFENSE P/U/SEC. 138 OF THE N.I.
