ORAL ORDER

(PER: THE HON'BLE MR. JUSTICE V.SRISHANANDA)

1. The matters are taken up for disposal on merits.
2. Taking note of the fact that, as against the cheque amount of ₹10,20,600/- in respect of both cheques which were subject matter of these proceedings, the accused has paid sum of Rs.13,20,000/- as on today, as agreed the fine amount in respect of both cheques, in a sum of Rs.16,32,960/-. As such fine amount is hereby reduced to Rs.13,20,000/- in all these matters
3. Accordingly, the order of the Trial Court, as confirmed by the First Appellate Court, is modified to the extent of the compensation in a sum of Rs.13,20,000/- which is paid by accused to complainant.
4. In view of the above, the petitions stand disposed of.
