CAV ORDER

The petitioner namely BDK Valves Pvt. Ltd. has maintained this petition under Section 24 of the Civil Procedure Code, 1908 read with Articles 226 and 227 of the Constitution of the India for the following reliefs:

- "A. Call for records of Industrial Disputes from the files of the Labour Court, Hubballi, more fully described in the Schedule-I hereunder.*
- B. Consequently, transfer the said industrial disputes to the Industrial Tribunals constituted under Section 44 of the Industrial Relations Code, 2020, giving full and actual affect to Section 51 of the Industrial Relations Code 2020.*
- C. Grant cost of the CP petition.*
- D. Pass any other appropriate order or direction as the Hon'ble Court deems fit to grant, under the circumstances of the case in the interest of justice."*

2. Initially, the petitioner had maintained the petition in CP No.100040/2026 by arraigning 163 persons as the respondents. At the time of registration of the said petition, the office raised an objection regarding

maintainability of single petition when the petitioner has sought transfer of the cases pending against all the respondents. Later, i.e., 15.04.2026, an order came to be passed directing the petitioner to file separate set of petitions in respect of each of the respondents and to pay separate court fee as per the Order dated 18.02.2026. Pursuant the same, the petitioner filed separate set of petitions against the respondents at Sl.Nos.1 to 140 and 162. Accordingly, the connected petitions came to be registered.

3. The relief sought in all these petitions is common and based on same set of facts and law. As such all these petitions are taken up for consideration together.

4. The petitioner is a Private Limited Company. The respondents were the workmen under the petitioner. On 27.11.2024 the petitioner terminated the services of the respondents on the ground of grave misconduct, allegedly arising out of their participation in an illegal strike organized by a Trade Union. Consequent upon the termination, the Trade Union namely M/s Weir BDK Valves Worker Union raised an industrial dispute before the Deputy Commissioner,

Belagavi challenging the dismissal of the workmen. The Government vide Order dated 15.11.2024 referred the said industrial dispute for adjudication to the Labour Court, Hubballi. Simultaneously, the respondents instituted individual industrial disputes under the provisions of the Industrial Disputes Act, 1947 (in short, 'ID Act') before the labour Court seeking redressal in respect of their dismissal from service.

5. Meanwhile, the Government of India notified the Industrial Relations Code, 2020 (in short, 'the Code') vide Notification No. S.O. 5320(E) dated 21.11.2025 with an object to consolidate and amend the laws relating to trade unions, conditions of employment in industrial establishment or undertaking, investigation and settlement of industrial disputes and for matters connected therewith or incidental thereto, having applicability throughout the country.

6. The enactment provides for constitution of one or more Industrial Tribunal for the adjudication of industrial disputes and for performing such other functions as may be assigned to them under the Code.

7. Section 51 of the Code deals with transfer of pending cases immediately before commencement of the Code in the Labour Court and the Tribunal, constituted under the ID Act, 1947 to the Tribunal having corresponding jurisdiction under the Code.

8. The Repeal and Savings in Section 104 of the Code stipulates that in the notification issued under Sub-Section (3) of Section 1 for the commencement of any provision of the Code, the Central Government may specify that the provisions of the Acts - a) the Trade Unions Act, 1926, b) the Industrial Employment (Standing Orders) Act, 1946, and c) the Industrial Disputes Act, 1947 shall stand repealed with effect from the date appointed in the notification in this behalf and the remaining provisions of the enactments referred above, shall remain in force till they are repealed by like notifications in the like manner. The said section also makes it clear that without prejudice to the provisions of Sub-Section (2), the provisions of Section 6 of the General Clauses Act, 1897 shall apply to the repeal of such enactments.

9. In addition, Section 103 of the Code stipulates that if any difficulty arises in giving effect to the provisions of the Code, the Central Government may by order published in the Official Gazette, make such provisions, not inconsistent with the provisions of the Code as may appear to it to be necessary for removing the difficulty, for a period of three years from the date of commencement of the Code.

10. The Central Government, in exercise of the powers conferred by Sub-section (3) of Section 1 of the Code, issued a notification, appointing the 21st day of November 2025 as the date on which the provisions of the Code shall come into force.

11. The Central Government, in exercise of powers conferred under Section 103 of the Code, issued a notification on 08.12.2025, the order called the Industrial Relations Code (Removal of Difficulties) Order, 2025, clarifying that the existing Labour Courts, Industrial Tribunals and National Tribunals constituted under the ID Act shall continue to adjudicate the existing as well as new cases, for the purpose of ensuring continuity of adjudication and awarding any legal or administrative vacuum until the

constitution of Industrial Tribunals and National Industrial Tribunals under the Code.

12. On 02.02.2026, the Central Government, in exercise of powers under Section 104 read with sub-section (3) of Section 1 of the Code, issued a notification specifying that the provisions of the Trade Unions Act, 1926, the Industrial Employment (Standing Orders) Act, 1946 and the Industrial Disputes Act, 1947 stand repealed with effect from the date appointed in the notification dated 21.11.2025.

13. The Central Government, in exercise of the powers conferred under Section 103 of the Code, issued one more notification on 02.02.2026 and partially modified the notification dated 08.12.2025 by way of further clarification. Under the said order i.e. the Industrial Relation Code (Removal of Difficulties)(Amendment) Order, 2026, it is clarified that all the existing statutory authority under the Trade Unions Act, 1926, the Industrial Employment (Standing Orders) Act, 1946 and the Industrial Disputes Act, 1947, shall continue to function until the appointment of such statutory authority under the Code for ensuring

continuity of functions, smooth transition and avoiding any legal or administrative vacuum.

14. The petitioner has narrated in detail about the notification of the Code by the Government of India as well as subsequent notifications issued i.e. Removal of Difficulties Orders, in the petition. The petitioner has also stated about the draft Industrial Relations (Karnataka) Rules, 2026 published by Government of Karnataka, in furtherance of Section 99 of the Code, notified on 23.01.2026, inviting public objection within 45 days from its publication.

15. In para 3.26 of the petition, the petitioner has averred about the legal position as it stands now as under:

- "i. Trade Unions Act, 1926, the Industrial Employment (Standing Orders) Act, 1946 and the Industrial Disputes Act, 1947 stands repealed with effect from 21st November 2025.*
- ii. Statutory authorities constituted under the repealed enactments continue to function until corresponding authorities are appointed under the IR Code.*
- iii. In view of Section 51 of the IR Code, cases pending as on the date of commencement of the Code stand transferred from Labour Courts,*

while cases instituted thereafter continue before the jurisdiction Labour Courts.

iv. However, proceedings before Labour Courts are no longer governed by the procedural frame work under the repealed statutes.”

16. In ***Glastronix LLP Vs The President/General Secretary, Glastronix Karmika Sangha and Others*** [NC:2026:KHC:7984], a coordinate bench of this Court, has dealt with the effect of the Code on a reference made under ID Act. It was a petition filed assailing Order dated 19.12.2025 issued by the Government of Karnataka, referring the dispute between the Petitioner and Employees' Union therein, for adjudication to the Industrial Tribunal, Bengaluru. In the said proceeding it was contended that the reference was invalid inasmuch as the Code was notified with effect from 21.11.2025 and that in terms of the Code, the Government has no jurisdiction to refer the dispute under the ID Act, 1947. In the said petition, this Court after considering all the contentions raised at the Bar, held that the plain reading of Section 51 of the Code indicates that all the Labour Courts and Tribunals constituted under the ID Act, 1947 shall not have any jurisdiction and the cases are to

be transferred to the Tribunals and the National Industrial Tribunals constituted under the Code.

17. At para 23 of the Order, learned Single Judge held that "... Though it is urged that the word 'Labour Court' is not found in Section 104(1A) of the Code, 2020 the Court is of the view that the expression statutory authorities found in Section 104(1A) would also include the Labour Courts." Accordingly, learned Single Judge concluded that notwithstanding the repeal of the Acts mentioned in Section 104(1A) of the Code, the Tribunals and statutory authorities functioning under the Acts so repealed will continue till the formation of Tribunals and other authorities under the Code.

18. Sri Shridhar Prabhu, learned Counsel appearing for the Petitioner, submitted that the Code came into operation from 21.11.2025 and the ID Act came to be repealed from the said date, pursuant to the notification issued under Sub-Section (3) of Section 1 of the Code. He drew the attention of this Court to Section 51 of the Code which stipulates that the cases transferred to the Tribunal shall be dealt with de novo or from the stage at which they were pending before such transfer and contends that as of

now proceedings before Labour Courts are no longer governed by the procedural frame work under the repealed statutes. On these grounds it is urged that the proceedings in question on the file of Labour Court, Hubballi be transferred to the Tribunal constituted under Section 44 of the Code, by giving full and actual effect to Section 51 of the Code. Alternatively, it is urged to stay all further proceedings of the matters on the file of Labour Court, Hubballi till establishment of the Tribunals under the Code.

19. Per contra, Sri Vishwanath Hegde, learned Counsel appearing for the Respondents vigorously submitted that the Central Government has issued orders in exercise of the powers under Section 103 of the Code, clarifying that existing Labour Courts, Industrial Tribunals as well and the existing statutory authorities under the repealed statutes shall continue to function until the appointment of corresponding authorities under the Code in order to ensure continuity of functions and avoid any legal or administrative vacuum. He further submitted that in W.P. No.104683/2025 and other connected matters [DD 19.01.2026], the petition filed by the petitioner herein challenging an order passed on

18.06.2025 by the Labour Court, Hubballi, this Court while disposing of those writ petitions vide Order dated 19.01.2026, has issued a direction to the Labour Court to endeavour to decide the pending reference along with the disputes within an outer limit of six months from the date of receipt of the copy of the Order and that the petitioner has maintained these petitions to delay the proceedings before Labour Court, Hubballi.

20. The main prayer of the petitioner in these petitions is to transfer all the industrial disputes pending before the Labour Court, Hubballi between them and the respondents, to the Industrial Tribunal constituted under Section 44 of the Code. Admittedly and as noted in the case of **Glastronix LLP** (referred supra), the Tribunals and the National Industrial Tribunals are not yet constituted under the Code. The general power conferred by Section 24 of the Code of Civil Procedure to withdraw a suit or proceeding cannot be exercised in isolation. Where withdrawal is permitted, the proceedings so withdrawn must be forthwith transferred to a court or forum competent to adjudicate the controversy and adjudication must proceed in accordance

with law. When the factual position shows that the Tribunals are not constituted under the Code, the power conferred by Section 24 of the Code of Civil Procedure is unavailable; accordingly, the question of exercising that power does not arise.

21. Further, the Tribunals created under special statutes like the ID Act are generally not considered subordinate civil courts, and as such, Section 24 CPC cannot be invoked to transfer the proceedings pending before the Labour Courts or the Industrial Tribunals. On the other hand, the transfer of the proceeding under the ID Act or the Code is governed by statutory provision made thereunder. Section 33B(1) of ID Act and Section 92(1) of the Code confers power with the appropriate government to transfer certain proceedings.

22. In addition, exercising the power under Articles 226 or 227 of the Constitution of India would arise when the transfer is sought on the grounds of bias, denial of natural justice or other special circumstances. Whereas, the primary contention of the petitioner in these petitions is that the Labour Court, Hubballi lacks the jurisdiction to conduct the

proceedings as the statutory provisions governing its procedures and the procedural framework stands repealed. The notifications dated 08.12.2025 and 02.02.2026 issued by the Central Government clarifies that existing Labour Courts, Industrial Tribunals as well as all the existing statutory authorities under the repealed statutes shall continue to function until the appointment of corresponding authorities under the Code in order to ensure continuity of functions and avoid any legal or administrative vacuum. Bearing in mind the aforementioned clarifications/Removal of Difficulties Orders passed under Section 103 of the Code, this Court is not inclined to accept the contention of the petitioner urged in para 3.26(iv) of the petition.

23. In the result, this Court proceeds to pass the following:
