respondent No.2 herein and she filed complaint
against her all sons and their family, except
petitioner herein. Even though there is no complaint
against petitioner, by looking genealogy of
respondent No.2, police filed charge sheet against all
sons including petitioner herein. Admitted fact as
even though respondent No.2 is residing with her
daughter, petitioners is giving monthly medical
expense. Considering this aspect, give liberty to
move discharge application before trial court in the
