1. Learned counsel for the petitioners has filed a memo for withdrawal. The memo reads as under:

"MEMO OF WITHDRAWAL

The Advocate on behalf of the petitioner most respectfully submits as follows:-

1. The petitioner herein had filed the petition seeking to quash the entire proceedings of Cr. No. 2 of 2025 registered at Vijayanagar District Lokayukta Police Station, Hosapete, In respect of the Offence Punishable U/s 13 (1) (C) (D) R/w 13(2) of prevention of corruption act R/w section 120 (B), 409, 465, 466, 468, of IPC 1862.

2. The petitioner intends to withdraw the present petition along with the permission to file fresh petition after the filing of charge sheet.
