- "i) Issue a writ of Mandamus directing the Respondents not to acquire or demolish the schedule property or part thereof without following the due process of law;*
- ii) Issue a writ of Certiorari quashing the notice bearing No.SO/HUHABO/KO.VI/RA.A/2/2021-22 dated 18.08.2021 issued by Respondent no.2 as per Annexure-F.*
- iii) Issue such other writ/order/direction as deems fit in the circumstances of the case, including costs, in the interest of justice."*
