ORAL ORDER

The petitioner/wife has filed this petition under Section 24 of the Civil Procedure Code, 1908, for seeking transfer of a case in O.S.No.13/2025, pending on the file of Principal Judge, Family Court, Dharwad, to the Court of Family Court at Haveri.

2. The respondent herein being husband of the petitioner has filed suit in O.S.No.13/2025, for restitution of conjugal rights, before the Principal Judge, Family Court, Dharwad.

3. The petitioner is residing at Haveri. She is a homemaker without having any source of income. The respondent/husband is private worker by profession. Therefore, he is having income. The petitioner being a woman is facing difficulty to travel from Haveri to Dharwad to attend the Court case. Whereas, the respondent/husband is able to travel from Dharwad to Haveri. Hence, the



petition is liable to be allowed. Accordingly, I proceed to pass the following:

ORDER

- i. The petition is ***allowed***.
- ii. The case in O.S.No.13/2025, pending on the file of Principal Judge, Family Court, Dharwad, is transferred to the Court of Family Court, Haveri, for disposal in accordance with law.
