ORAL ORDER

(PER: THE HON'BLE MR. JUSTICE HANCHATE SANJEEVKUMAR)

The petitioner/wife has filed this petition under Section 24 of the Civil Procedure Code, 1908, for seeking transfer of a case in M.C.No.13 of 2025, pending on the file of Senior Civil Judge, Mudhol, to the Court of Senior Civil Judge, Navalagund.

2. The respondent herein being husband of the petitioner has filed petition in M.C.No.13 of 2025, under Section 9 of the Hindu Marriage Act, 1955, for restitution of conjugal rights, before the Senior Civil Judge and JMFC, Mudhol.

3. The petitioner is residing at Badrapur village, Annigeri taluk. She is a homemaker without having any source of income. The respondent/husband is an agriculturist. Therefore, he is having income. The petitioner being a woman is facing difficulty to travel from Badrapur to Mudhol to attend the Court case. Whereas, the



respondent/husband is able to travel from Mudhol to Navalagund. Hence, the petition is liable to be allowed.

4. In the result, I proceed to pass the following:

ORDER

- i. The petition is ***allowed***.
- ii. The case in M.C.No.13 of 2025, pending on the file of Senior Civil Judge and JMFC, Mudhol, is transferred to the Court of Senior Civil Judge, Navalagund, for disposal in accordance with law.
- iii. No order as to costs.
