ORAL ORDER

1. Heard learned counsel Sri.Nagaraj Appannanavar, Sri.Praveena Y. Devareddyavar, learned High Court Government Pleader and Miss.Divya J. Deshpande, learned counsel appearing for Sri.Girish A. Yadwad, for the parties.

2. The petitioners in Criminal Petition No.10460/2025 and Criminal Petition No.104793/2025 are not agreeable for an amicable settlement, whereas the petitioners in Criminal Petition No.104314/2025 and Criminal Petition No.104318/2025 have expressed their willingness for amicable settlement.

3. These matters arise out of a cases and counter cases.

4. Having noted the fact that the parties are not seeing eye to eye for an amicable settlement, there cannot be any order of quashing the pending criminal proceedings, in view of the principles of law enunciated by the Hon'ble Full

5. Accordingly, all the criminal cases which are the subject matter of these petitions shall be proceeded with by the learned Trial Judge in accordance with law, strictly following the guidelines issued by the Full Bench of this Court in ***Hosakeri Ningappa*** (supra).

6. Accordingly, the following order is passed:

ORDER

(i) The petitions are dismissed.

(ii) However, the learned Trial Judge shall conduct the trial in respect of all these cases strictly in accordance with the guidelines issued by the Full Bench of this Court in ***Hosakeri Ningappa*** referred to supra.
