ORAL ORDER

(PER: THE HON'BLE MR. JUSTICE HANCHATE SANJEEVKUMAR)

The petitioner/wife has filed this petition under Section 24(1) of the Civil Procedure Code, 1908, for seeking transfer of a case in O.S.No.12/2025, pending on the file of Principal Judge, Family Court, Haveri, to the Court of Family Court at Hubballi.

2. The respondent herein being husband of the petitioner has filed suit in O.S.No.12/2025, for restitution of conjugal rights, before the Principal Judge, Family Court, Haveri.

3. The petitioner is residing at Hubballi. She is a homemaker without having any source of income. The respondent/husband is an agriculturist and an advocate by profession. Therefore, he is having income. The petitioner



being a woman is facing difficulty to travel from Hubballi to Haveri to attend the Court case. Whereas, the respondent/husband is able to travel from Haveri to Hubballi. Hence, the petition is liable to be allowed. Accordingly, I proceed to pass the following:

ORDER

- i) The petition is allowed.
- ii) The case in O.S.No.12/2025, pending on the file of Principal Judge, Family Court, Haveri, is transferred to the Court of Family Court, Hubballi, for disposal in accordance with law.
- iii) No order as to costs.
