ORAL ORDER

The present writ petition is filed seeking for the following reliefs:

"Wherefore the Petitioner prays that the Hon'ble Court may be pleased to:

A) Issue a Writ in the nature of Certiorari quashing the mutation entry bearing M.E No 3222 dated 11-12-1961 a copy of which is produced as per Annexure-D;

B) Issue a Writ in the nature of Mandamus directing the Respondents to re-enter the name of the Petitioner to the revenue records of the petition land bearing R.S No 21 measuring 4 Acres 7 Guntas situated at Tung Village of Jamakhandi Taluka in the interest of justice;

C) Any appropriate Writ/Order or direction as deemed fit and proper be issued."

2. It is forthcoming that the relief (A) sought for in the present petition is seeking to impugn M.E.No.3222 dated 11.12.1961. An alternative remedy is available to the petitioner as contemplated under Section 136(2) of the Karnataka Land Revenue Act, 1964.
