ORAL ORDER

The petitioner/wife has filed this petition under Section 24 of the Civil Procedure Code, 1908, for seeking transfer of a case in M.C.No.93 of 2025, pending on the file of Principal Senior Civil Judge and JMFC, Ranebennur, to the Court of Senior Civil Judge and JMFC, Chitradurga.

2. The respondent herein being husband of the petitioner has filed petition in M.C.No.93 of 2025, under Section 13(1) (ia) (ib) of the Hindu Marriage Act, 1955, for dissolution of marriage, before the Principal Senior Civil Judge and JMFC, Renebennur.

3. The petitioner is residing at Chitradurga and the petitioner being a woman having no source of income. The respondent/husband is a businessman. Therefore, he is having income. The petitioner being a woman is facing difficulty to travel from Chitradurga to Ranebennur to attend the Court case. Whereas, the respondent/husband is



able to travel from Ranebennur to Chitradurga. Hence, the petition is liable to be allowed.

4. In the result, I proceed to pass the following:

ORDER

- i. The petition is ***allowed***.
- ii. The case in M.C.No.93 of 2025, pending on the file of Principal Senior Civil Judge and JMFC, Ranebennur, is transferred to the Court of Principal Senior Civil Judge and JMFC, Chitradurga, for disposal in accordance with law.
- iii. No order as to costs.
