ORAL ORDER

The petitioner is before this Court seeking review of the order dated 21.02.2025 passed by this Court in W.P. No.107663/2024, which was considered along with the lead petition - W.P. No.101017/2025 and two other petitions, by



following the earlier orders that were passed by the coordinate benches of this Court.

2. The petitioner - Executive Engineer of Works Division, Karnataka State Road Transport Corporation was arrayed as respondent No.3 in W.P. No.107663/2024.

3. Though there is no warrant to review the said order except the fact that the review petitioner was not heard in the matter, the Review Petition stands **allowed**. The order dated 21.02.2025 passed in W.P. No.107663/2024 stands recalled and the matter is ordered to be posted before the Bench having roster to afford an opportunity to the review petitioner to place his submissions before the concerned Court.

It is ordered accordingly.
