2. Counsel for the petitioners submits that the petition may be disposed of in terms of the order dated 04.12.2025 passed by the Co-ordinate Bench of this Court in Writ Petition Nos.106191 of 2024 C/w 107317 of 2024.

3. Urging other contentions, AGA submits that a suitable order may be passed.

4. Heard the arguments and perused the papers with care.

5. Taking note of the issue involved in the present writ petition, the writ petition is ***disposed of*** in terms of the order passed by the Co-ordinate Bench of this Court in Writ Petition Nos.106191 of 2024 C/w 107317 of 2024.
