THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO ISSUE A WRIT OF CERTIORARI QUASHING ANNEXURE-A, VIZ. THE INELIGIBLE VOTERS LIST OF RESPONDENT NO.9 SOCIETY PUBLISHED BY THE RESPONDENT NO.5 AND 9 IN SO FAR AS THE PETITIONERS HEREIN ARE CONCERNED. B) ISSUE A WRIT IN THE NATURE OF MANDAMUS DIRECTING THE RESPONDENTS TO CONDUCT THE ELECTIONS TO THE RESPONDENT NO.9 SOCIETY IN ACCORDANCE WITH LAW I.E. STRICTLY IN ADHERENCE OF PROCEDURE PRESCRIBED UNDER THE KARNATAKA CO-OPERATIVE SOCIETIES ACT AND RULES. C) ISSUE A WRIT IN THE NATURE OF MANDAMUS DIRECTING THE RESPONDENT NOS. 5, 8 AND 9 TO INCLUDE THE NAMES OF THE PETITIONERS IN THE ELIGIBLE VOTERS LIST AT ANNEXURE-D.

ORAL ORDER

Heard learned counsel for the petitioners, learned Additional Advocate General along with Government Advocate for respondent-State and learned counsel for private respondents.

2. This petition is filed seeking the following reliefs:



- "a) *Issue a writ order or direction in a nature of certiorari quashing Annexure-A, viz, the ineligible voters list of respondent No.9 society published by respondent No.5 and 9 insofar as the petitioners herein are concerned.*
- b) *Issue a writ in the nature of Mandamus or any other appropriate writ, order or direction, directing the respondents to conduct the elections to the respondent No.9 society in accordance with law i.e., strictly in adherence of procedure prescribed under the Karnataka Co-operative Societies Act and Rules.*
- c) *Issue a writ in the nature of mandamus directing the respondent Nos.5, 8 and 9 to include the names of petitioners in the eligible final list at Annexure-D.*
- d) *Pass such other orders as may be appropriate in the facts and circumstances of the case, in the ends of justice and equity."*

3. Petitioners claim to be the members of respondent No.9 - Society, namely, Multipurpose Primary Rural Agricultural Co-operative Society Limited, Madabal, Sindagi Taluk, Vijayapur District, registered under the Provisions of Karnataka Co-operative Societies Act, 1959 (for short, 'the Act'). It is contended that Co-operative Society totally consists of 2692 borrower members. among them, the petitioner Nos.1 to 333 are members. The said society has a Managing Committee of 12 seats including



the President, Vice President, and 09 directors. The petitioners are shareholders and members of the said society under the category of borrower members. Respondent No.9 prepared eligible and ineligible voters' list and sent it for approval to respondent No.6. Thereafter, respondent-Society published the eligible and ineligible voters list wherein, 1038 members were eligible voters and 1654 were ineligible voters out of 2692 members. Thereafter, the Returning Officer issued calendar of events to hold elections to the Co-operative Society. As per the calendar of events dated 12.12.2024, the last date for filing of nomination was on 04.01.2025; last date for withdrawal of nomination was on 06.01.2025 and Elections were scheduled to be conducted on 12.01.2025.

4. The petitioners being aggrieved by the ineligible voters list published and in view of violation of Rule 13D of the Karnataka Co-operative Societies Rules, 1960, approached this Court. Vide interim order dated



09.01.2025, this Court permitted the petitioners to cast their votes in the ensuing elections which was scheduled on 12.01.2025. However, it was ordered that the votes cast by the petitioners be kept in a separate ballot box and shall not be counted. The Returning Officer was permitted to proceed with the declaration of the results. However, the same was subject to outcome of this petition. In view of said interim order, the votes cast by the petitioners are yet to be counted as the same are kept in a separate ballot box.

5. In view of the fact that the elections are over and the results are announced, the votes of the petitioners which, at the instance of an interim order, are kept in a separate ballot box, are not taken into consideration for counting. Learned counsel for the petitioners contends that the ineligible voters who have approached this Court and whose votes have been kept in a separate ballot boxes to be taken into account and the results be declared accordingly.



6. Learned Additional Government Advocate representing the State contends that the present petition itself is not maintainable as there is an alternative and efficacious remedy available under Section 70 of the Act for the petitioners in case of any dispute arises with regard to the election process. This Court in several judgments have pronounced that any challenge made to the Election process or Management of the Co-operative Society, the petitioners would be entitled to raise a dispute under Section 70 of the Act. Having not done so, it may not be appropriate for this Court to intervene in the election process once it has already begun. It is open to the petitioners to approach the Registrar under Section 70 of the Act. The Registrar shall decide the validity of the votes cast by the petitioners, which have been kept in separate ballot boxes, in accordance with law, within six months from the date of receipt of a copy of this order.

7. It is made clear that the Registrar, while dealing with such petitions, if any filed, shall pass orders



expeditiously, after affording an opportunity of hearing to the parties concerned. Accordingly, writ petition stands ***disposed of.***

8. Ordered accordingly.
