ORAL ORDER

This contempt petition is filed alleging non-compliance of the order dated 06.08.2025 passed by the learned Single Judge of this Court in W.P.No.201859/2024.

2. The complainant had filed W.P.No.201859/2024 to quash the mutation order dated 30.09.2010 in M.R.No.08/2010-2011 in respect of Sy.No.21/2 of Hondadaddi Village, Bidar taluk and to restore the same in the name of the complainant and to set aside the order dated 04.08.2023 passed by respondent No.2 therein and to direct the respondents therein to consider her request and representation dated 14.09.2025.

3. The said writ petition was disposed of in terms of an order dated 06.08.2025 by which, the respondents



were directed to restore the name of the petitioner in the revenue records.

4. The complainant contends that the said order is not complied with and is therefore, before this Court.

5. When this petition is listed for orders, the learned Principal Government Advocate has filed a memo and enclosed therewith an order complying the order passed by the learned Single Judge.

6. In that view of the matter, this contempt petition is ***closed***.
