ORAL JUDGMENT

Learned counsel for the appellant in MFA No.201232/2022 submits that both the appellant/insurer and the claimant settled the matter and a joint memo to that effect is already filed and the appellant has agreed to pay compensation of Rs.5,41,000/- to the claimant towards full and final settlement inclusive of amount already deposited before the Tribunal under conditional stay.
