NO.170/1696/2019 BY THE CENTRAL ADMINISTRATIVE TRIBUNAL AT BANGALORE, VIDE ANNEXURE-D B) TO ISSUE WRIT OF CERTIORARI QUASHING THE SELECT LIST OF GDS FOR KARNATAKA CIRCLE ISSUED VIDE NOTIFICATION NO. R&E/2-94/GDS ONLINE/CYCLE-11/2019, DATED 5-8-2019 BY THE CPMG BG, AT ANNEXURE-A6 ONLY TO THE EXTENT OF SELECTION OF RESPONDENT NO.5 TO THE POST OF GDS BPM, KAMALAPURA BO A/W YERGERA SO UNDER RAICHUR HO, IN VIEW OF THE FACT THAT THE PETITIONER HAS ALREADY BEEN ENGAGED TO WORK AGAINST HE SAID POST ON STOP GAP ARRANGEMENT BASIS SINCE 1-9-2015 CONTINUOUSLY FOR MORE THAN 6 YEARS WITHOUT ANY BREAK C) TO ISSUE WRIT OF MANDAMUS DIRECTING THE RESPONDENTS NO.2 TO 4 TO REGULARIZE THE SERVICES OF THE PETITIONER AGAINST THE VACANT POST OF GDS BPM, KAMALAPURA BO IN A/W YERGERA SO UNDER RAICHUR HO IN VIEW OF THE FACT THAT PETITIONER HAS BEEN WORKING IN THE SAID POST SINE MORE THAN 6 YEARS.
