THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING THAT THIS Hon'ble COURT MAY BE PLEASED TO A) ISSUE A WRIT OF MANDAMUS DIRECTING THE RESPONDENT NO.4 TO CONSIDER THE REPRESENTATION DATED 13.04.2026 VIDE ANNEXURE-A AND PASS APPROPRIATE ORDERS ON THE PETITIONERS APPLICATION FOR REGULARIZATION UNDER (AKRAM-SAKRAM) VIDE APPLICATION RECEIPT NO.BHM3981AB3F28B3F DATED 10.10.2022 IN RESPECT OF SY.NO.401, MEASURING 5 ACRES 00 GUNTAS SITUATED AT SIDDAPUR K VILLAGE, TIKOTA TALUK, VIJAYAPURA DISTRICT WITHIN A STIPULATED PERIOD; B) PASS SUCH OTHER ORDER OR DIRECTION AS THIS HONOURABLE COURT DEEMS FIT IN THE INTEREST OF JUSTICE AND EQUITY.

ORAL ORDER

Petitioner is before this court under Article 226 of the Constitution of India seeking for the following reliefs :

- a) Issue a writ of mandamus directing the respondent No.4 to consider the representation dated 13.04.2026 vide Annexure-A and pass appropriate orders on the petitioners application for regularization under (Akram-Sakram) vide application receipt No.BHM3981AB3F28B3F dated 10.10.2022 in respect of Sy.No.401, measuring 5 acres 00 guntas situated at Siddapur K village,



Tikota taluk, Vijayapura district within a stipulated period;

- b) Pass such other order or direction as this Hon'ble Court deems fit in the interest of justice and equity.

2. Heard the learned counsel for the petitioner and learned Additional Government Advocate on behalf of respondents.

3. Learned Additional Government Advocate submits that the application filed by the petitioner on 10.10.2022 for regularization of her unauthorized occupation and cultivation of the land in question has been rejected vide endorsement dated 31.01.2026.

4. Said submission is placed on record.

5. Writ petition is therefore **dismissed** with liberty to the petitioner to challenge the said endorsement in accordance with law.
