ORAL ORDER

"i) Issue a writ in the nature of mandamus thereby directing the court below the written statement shall be taken as not filed and post the matter for evidence of plaintiffs in OS No.163/2025;

ii) Pass any other order or direction as this court deems fit in view of the facts and circumstances of the case, in the interest of justice and equity."



2. After arguing the matter for sometime, learned counsel for the petitioners seeks permission to withdraw the petition reserving liberty in favour of the petitioners to approach this Court subsequently if the occasion so arises after appropriate orders are passed by the Trial Court.
