RESPONDENT NO.2 TO CONSIDER THE REPRESENTATION GIVEN BY THE PETITIONER ON DATED 26.05.2026 VIDE PRODUCED AND MARKED AS VIDE AT ANNEXURE-D, B) A WRIT OF MANDAMUS TO ISSUE THE DIRECTION TO THE RESPONDENT NO.1 TO CONSIDER THE REPRESENTATION GIVEN BY THE PETITIONER ON DATED 02.06.2026 VIDE PRODUCED AND MARKED AS VIDE AT ANNEXURE-E, C) ISSUE ANY OTHER WRIT OR ORDER OR DIRECTION TO MEET THE ENDS OF JUSTICE UNDER THE FACTS AND CIRCUMSTANCES OF THE CASE, IN THE INTEREST OF JUSTICE AND EQUITY.

ORAL ORDER

Though the matter is posted for preliminary hearing, with the consent of both sides, the matter is taken up for final disposal and disposed of by this order.

2. In this petition, the petitioner has sought for the following reliefs:

"a) A writ of mandamus to issue the direction to the Respondent No.2 to consider the representation given by the petitioner on dated 26.05.2026 vide produced and marked as vide at Annexure-D.

b) A writ of mandamus to issue the direction to the Respondent No.1 to consider the representation



given by the petitioner on dated 02.06.2026 vide produced and marked as vide at Annexure-E.

c) Issue any other writ or order or direction to meet the ends of justice under the facts and circumstances of the case, in the interest of justice and equity."

3. Heard learned counsel for the petitioner and learned Additional Government Advocate for the respondents and perused the material on record.

4. It is the grievance of the petitioner that his representations dated 26.05.2026 and 02.06.2026 at Annexures-D & E submitted to the respondents have not been considered so far by them nor any order has been passed on the same. Under these circumstances, the petitioner is before this Court by way of the present petition.

5. *Per contra*, learned counsel for the respondents submits that if reasonable time is given, they would consider and pass necessary order on the said representation.



6. In view of the aforesaid facts and circumstances and rival submissions, the respondents are hereby directed to address the grievances of the petitioner and consider his representations dated 26.05.2026 and 02.06.2026 at Annexures-D & E and pass appropriate order in accordance with law, within a period of three months from the date of receipt of a copy of this order.

7. With the aforesaid directions, the petition stands ***disposed of.***
