THIS WRIT PETITION IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA, PRAYING TO A) SET ASIDE THE FINAL DECREE DATED 21.07.2015 PASSED IN FDP NO.11/2014 ON THE FILE OF THE ADDL. SENIOR CIVIL JUDGE, RAICHUR, INsofar AS IT AFFECTS THE RIGHTS AND INTERESTS OF THE PETITIONERS WHO WERE NOT MADE PARTIES TO THE SAID PROCEEDINGS; B) DIRECT THE TRIAL



COURT TO IMPLEAD THE PRESENT PETITIONERS AS PARTIES IN FDP NO.11/2014 AND TO RECONSIDER THE FINAL DECREE PROCEEDINGS AFRESH AFTER AFFORDING DUE OPPORTUNITY TO THE PETITIONERS; C) PASS SUCH OTHER ORDER OR DIRECTION AS THIS COURT DEEMS FIT IN THE INTEREST OF JUSTICE AND EQUITY, INCLUDING INTERIM PROTECTION OF THE PETITIONERS' SHARE IN SY.NO.191 OF ASKIHAI VILLAGE, RAICHUR TALUK AND DISTRICT.

ORAL ORDER

1. This Writ Petition is filed with a prayer to quash the final decree dated 21.07.2015 passed in FDP No.11/2014 by the Court of Additional Senior Civil Judge, Raichur.

2. Registry has raised an office objection with regard to the maintainability of this writ petition on the ground that the petitioners have an alternate efficacious remedy



of filing an appeal as against the order passed in FDP No.11/2014.
