ORAL ORDER

Heard the learned counsel for both the parties.
Perused the relevant materials on record.

2. The petition is filed under Section 24 of CPC praying for an order to transfer the petition in MC No.314/2024 on the file of District Judge Family Court, Kalaburagi to the Family Court, Raichur.

3. The petitioner herein is wife and she is the respondent before the Family Court, Kalaburagi in the petition filed by the petitioner (the respondent herein) under Section 9 of Hindu Marriage Act.

4. Learned counsel for the respondent submits that he has no objection to allow the petition. In view of the fact that the respondent has no objection to the



petition, there is no reason to disbelieve the contention of the petitioner put forth in the petition. Hence, the petition deserves to be allowed.
