This contempt petition is filed alleging non-compliance of the order dated 12.07.2025 passed by this Court in W.P.No.201676/2025.

2. The complainant had filed W.P.No.201676/2025 to consider his representation to close the rowdy sheet in his name. The writ petition was disposed off in terms of an Order dated 12.07.2025, by which the respondents therein were directed to consider the representation of the complainant. The complainant claims that said representation is not considered, and therefore he is before this Court in this contempt petition.

3. Learned Principal Government Advocate today files a memo alongwith a copy of the order dated 17.02.2026 passed by the respondent No.3 and submits that following the directions issued by the learned Single Judge, the representation of the complainant was considered and the name of the complainant was removed from the rowdy sheet.
