THIS WRIT PETITION IS FILED UNDER ARTICLES 226 & 227 OF THE CONSTITUTION OF INDIA, PRAYING TO DIRECT THE RESPONDENTS TO CONSIDER THE REPRESENTATION AT ANNEXURE-C DATED 30.08.2025.

ORAL ORDER

1. This writ petition under Articles 226 & 227 of the Constitution of India is filed seeking writ of mandamus directing the respondents to consider the representation of the petitioner at Annexure-C dated 30.08.2025.

2. Heard the learned Counsel for the parties.

3. Petitioner who has been allotted a shop by the respondent appears to have submitted a representation on 30.08.2025 vide Annexure-C to reduce the monthly rent of the shop allotted to him. According to the petitioner, similarly situated other allottees are paying lesser rent, and therefore, he has submitted the representation at Annexure-C dated 30.08.2025.

4. Sri Krupa Sagar Patil, learned Counsel appearing for respondent nos.2 & 3 submits that the allottees had



volunteered to pay rent fixed by the authorities to the shops allotted to them, and therefore, they cannot seek reduction of rent. He, however, submits that if some reasonable time is granted, petitioner's representation at Annexure-C dated 30.08.2025 shall be considered by respondent no.3 and appropriate orders would be passed in accordance with law.

5. The aforesaid submission is placed on record.

6. Writ petition is allowed. A direction is issued to respondent no.3 to consider the representation of the petitioner at Annexure-C dated 30.08.2025, as expeditiously as possible, but not later than a period of three months from the date of receipt of the copy of this order.
