2. Sri. Sanganabasava B. Patil, learned counsel appearing for the respondents, submits that, for execution of the award impugned in these appeals, execution proceedings were initiated before the Execution Court in E.P. No.241/2020 on the file of the Senior Civil Judge, Vijayapura.
