**JUDGMENT**

*Dated this the 26<sup>th</sup> day of March, 2024*

The claim in the writ petition is for compensation payable to the petitioner under Section 66 of the Disaster Management Act, 2005 for taking over their hospital, hostel, equipments and instruments, etc. during the Covid pandemic. Admittedly, amounts are due to the petitioner Trust, since their property had been used for the purpose of Covid recovery. Annexure R2(c) is the calculation made by the officers of the respondents.

2. The Government Pleader submits that amounts are due to the Government under different revenue recovery actions initiated against the petitioners. It is submitted that amounts are due under property tax to the Panchayat for which steps have been initiated for recovery and amounts are also due to the students, who were sent to other colleges.

3. The petitioner has produced Ext.P40 letter along with I.A No.1/2024 in W.P.(C) 6635/2024 wherein it is stated

that the amounts payable to students have been paid and no further amounts are due from the SR Medical Collage. As far as revenue recovery proceedings for recovery of property tax is concerned, it is submitted by the counsel for the petitioner that the proceedings have already been stayed by this Court. The Government is free to initiate any action for recovery of amounts due, but, that cannot be a reason for not paying the amounts which are admittedly due from the Government to the petitioners under the Disaster Management Act.

In the above circumstances, the writ petition is disposal of with a direction to the respondents to pay the amounts which have been claimed in Annexure R2(c) to the petitioners within three months from today.
