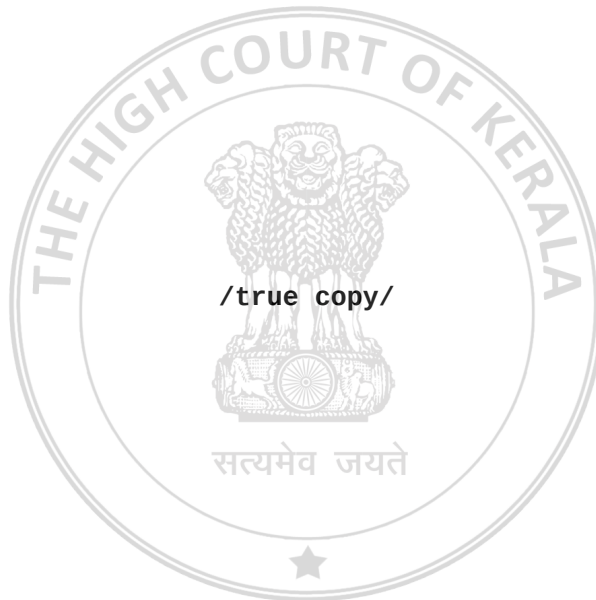
Learned Government Pleader takes notice for respondents.
