No.18 of 2008, Crl.A. No.20 of 2008, Crl.A. No.2 of 2008, Crl.A. No.2 of 2009, Crl.A. No.23 of 2008, Crl.A. No.3 of 2008, Crl.A. No.4 of 2008, Crl.A. No.8 of 2008 & Crl.A. No.9 of 2008.

Ms. Ashapriya, learned counsel, submits that she is for the appellants in 3(three) appeals viz., Crl.A. No.15 of 2008, Crl.A. No.22 of 2008 & Crl.A. No.3 of 2009.

Mr. W. Darakeshwar, learned Sr. Panel Counsel along with Ms. S. Nancy, learned State counsel for CBI/respondent in all the 21 appeals is before this Court.
