01.           1.           The ABLAPLs are disposed of by the following order.
2.           Heard learned counsel for the respective parties.
3.           Instant petitions have been filed under Section 482 BNSS by the petitioners seeking pre-arrest bail in connection with Telkoi P.S. Case No.322 of 2025 corresponding to G.R. Case No.312 of 2025 pending in the court of learned J.M.F.C., Telkoi on the grounds stated.
4.           Gone through the FIR at Annexure-1 and the allegations made therein. It is submitted to the Court that the petitioners are traders of cattle. As per the allegation levelled in Annexure-1, cattle were found transported in three Bolero vehicles at the relevant point of time and it was intercepted by the local police. It is informed to the Court by learned counsel for the petitioners that the petitioners do have other antecedents. The petitioners are local residents as made to reveal from the record. Considering the above facts and the allegations levelled as per Annexure-1, recording the objection of the State, the Court is not inclined to grant pre-arrest bail but to direct the petitioners to surrender before the court of learned J.M.F.C., Telkoi in connection with G.R. Case No.312 of 2025 corresponding to Telkoi P.S. Case No.322 of 2025 for being



released on bail upon furnishing bail bonds of Rs.50,000/- (rupees fifty thousand) each with one solvent surety for the like amount each to the satisfaction of the court concerned with such other conditions impose including a condition that they shall not be involved in any such similar nefarious activities after being released and accordingly, it is ordered.

5. All the ABLAPLs are disposed of.
