1. Heard Mr. B.Routray and Mr. G.Mishra, learned Senior Counsels for the Petitioners, Mr. S.K.Das, learned counsel and other respective counsels for the Intervenors and Mr. T.K.Dash, learned AGA for the State.

2. Upon hearing all the parties, interim order dated 19th May 2026 passed in W.P.(C) No.15500 of 2026 is modified to the extent that, seventeen (17) posts of Sevaks/ Sevikas (13 posts in



SEBC category, 02 posts in S.C. category, 01 post in S.T. category and 01 post in U.R. category) pursuant to advertisement dated 27th December 2024 at Annexure-1 may be kept vacant, till 2nd September 2026.

3. Similarly, in W.P.(C) No. 23101 & 23778 of 2026, one post of Sevak in SEBC category and one post of Sevika in S.C. category respectively, pursuant to advertisement dated 27th December 2024 at Annexure-1 may be kept vacant, till 2nd September 2026

4. The interim orders passed in W.P.(C) Nos.8695 and 8993 of 2026 earlier shall continue till 2nd September 2026.

5. As prayed on behalf of the intervenors, the State is at liberty to proceed in the selection process. List on 2nd September 2026.
