02. **I.A. Nos.7208 of 2026 & 7209 of 2026**

1. These matters are taken up through hybrid mode.
2. These I.As have arisen out of WP(C) Nos.9615 of 2026 and 9635 of 2026 for proper and effective implementation of the order passed on dated 09.04.2026 in WP(C) Nos.9615 of 2026 and 9635 of 2026.
3. The Petitioners have filed these I.As for some corrections in order to direct the Opposite Party No.1 (State of Odisha) instead of Opposite Parties 2 and 3 (Collector, Cuttack and Civil Supplies



Officer, Cuttack) to extend the period of their token in purchasing the amount of paddy indicated in their respective tokens.

4. Heard learned counsel for the Petitioners and the learned Addl. Government Advocate for the State.

5. When the Petitioners have filed these I.As for proper and effective implementation of the order passed on dated 09.04.2026 in WP(C) Nos.9615 of 2026 and 9635 of 2026 by the Opposite Party No.1 (State of Odisha) by taking decision in respect of the same without making any prayer for changing other portion of the said order, then, I find no justification to disallow these I.As filed on behalf of the Petitioners.

6. Hence, these I.As filed by the Petitioners are allowed.

7. In Para-7 of the order on dated 09.04.2026 passed in WP(C) Nos.9615 of 2026 and 9635 of 2026, necessary corrections shall be made directing the Opposite Party No.1 (State of Odisha) to extend the period of the token of the Petitioners for purchasing the amount of paddy indicated in the respective tokens without causing any inconvenience and harassment to them (Petitioners) in any manner and shall take decision in respect of the same on the very day of production of the certified copy of this corrected order along with the earlier order dated 09.04.2026 passed in WP(C) Nos.9615 of 2026 and 9635 of 2026 after excluding the last portions of that Para No.7.

8. As such, these I.As are disposed of finally.
