2. The subject matter of these Writ Appeals is substantially similar to the one dealt with by a Coordinate Bench of this Court in Writ Appeal No.1323 of 2023 (**State of Orissa v. Chhabindra Kumar Samal**) disposed off on 02.07.2025 in the light of the decision of the Apex Court in SLP(C) No.13077 of 2020 between **State of Orissa v. Amit Kumar Mishra**, decided on 12.01.2021. There is not much dispute on this position.



In the above circumstances, these Writ Appeals fail and are accordingly disposed off with a direction to implement the impugned orders of the learned Single Judge within an outer limit of three months and without giving any scope for contempt proceedings.
