2. Perused the minutes at Flag-2, wherein the Hon'ble Chief Justice has been pleased to assign this matter to this Bench for analogous hearing along with other connected matters.

3. Today, when the matter is taken up, it is pointed out at the Bar that W.P.(C) No.7085 of 2020 being related to School and Mass Education Department has no connection with the present batch of matters. On perusal of Office Note in W.P.(C) No.1550 of 2020, it appears that notice could not be served on certain opposite parties. As such, fresh steps are required to be taken in the said matter. As against W.P.(C) No.5222 of 2020, Office note shows that requisites for issuance of notice to Opposite Party Nos.3 to 14 except Opposite Party No.9 have not been filed. Therefore, these matters are not ready for hearing and the same are required to be delinked from the batch of matters, *i.e.*, W.P.(C) No.13391 of 2023.

3.1. It is also pointed out at the Bar that W.P.(C) No.13391 of 2023, WPC(OAC) No.3649 of 2017, WPC(OAC) No.558 of 2019 and W.P.(C) No.13388 of 2023 are not assigned to this Bench presently, where gradation list in respect of the Odisha Armed Police (Method of Recruitment & Conditions of Service) Rules, 2013 is under challenge.

4. Registry is instructed to place the bunch of matters before the Hon'ble the Acting Chief Justice for obtaining appropriate instructions.
