01. **1.** Heard learned counsel for the Petitioner.

It is submitted by learned counsel for the Petitioner that inadvertent typographical error has crept into the Index page of the petition wherein Annexure-3 has been mentioned as C.P. No.34/2026 instead of MAT Case No.34/2025. He seeks leave to correct the cause title by carrying out necessary correction in pen. Leave granted.

2. Learned counsel for the Petitioner shall carry out necessary correction which shall bear his initials to be counter signed by the Court Master.

3. The Petitioner-wife in the marriage seeks transfer of MAT Case No.34 of 2025 pending before



the learned Senior Civil Judge, Nilgiri, Balasore to the Court of learned Family Judge, Baripada, Mayurbhanj.

The MAT Case No.34 of 2025 has been filed by the husband in the marriage under Section 13(A) of the Hindu Marriage Act, 1955 seeking dissolution of the marriage solemnized between the parties on 16.02.2021 as well as grant of decree of divorce.

4. It is submitted that C.P. No.177 of 2025 filed by the wife under Section 9 of the Hindu Marriage Act is pending before the learned Judge, Family Court, Baripada at Mayurbhanj. She has sought for monthly maintenance under Section 125 of Cr.P.C. which is pending as Cr.P. No.212 of 2024 before the learned Judge, Family Court, Baripada at Mayurbhanj. It is submitted that in interest of justice all the matters should be tagged together. The Petitioner finds difficult to attend the matter at Nilgiri.

5. Issue notice to the Opposite Party, along with this order.

6. Requisites for issuance of notice to the Opposite Party by Speed Post with Registration and Proof of Delivery shall be filed within five working days. Returnable date be fixed to 30.06.2026.

The matter shall be listed in the week commencing 6th July, 2026.

7. Heard learned counsel for the Petitioner.

8. Issue notice as above.

Accept one set of process fee as well as postal requisites along with the petition.

10. As an interim measure, it is directed that further proceeding in MAT Case No.34 of 2025 pending before the learned Senior Civil Judge, Nilgiri, Balasore and C.P. No.177 of 2025 pending before the learned Judge, Family Court, Baripada shall be adjourned to a date beyond 13.07.2026 as would be convenient to the learned courts in seisin of the matters.

The matter shall be listed in the week commencing 6th July, 2026.
