- 1.** It is submitted by the learned Senior Counsel that though the matter is yet to be admitted and notice is to be issued after advance copy has been served/ scanned copy forwarded to the sole Opposite Party-Registrar, Civil Court, Ganjam, counter affidavit dated 12.05.2025 filed on 13.05.2025. The counter affidavit is on record, copy has been already served on the learned instructing Counsel.
 - 2.** Referring to the said affidavit, learned Senior Counsel submits that at paragraph-15, it is clearly stated that the examination was cancelled as per letter dated 25.04.2025 issued by the Registry of the Orissa High Court. Therefore, the High Court in its administrative side has to be made a party. It is further stated that the District Judge, Ganjam is also a necessary party.



3. We allow the oral prayer to implead the Registrar General, Orissa High Court as Opposite Party No.2 and District Judge, Ganjam as Opposite Party No.3. Necessary addition shall be made by the learned counsel for the Petitioner in the cause title to be countersigned by the Court Master.

4. Notice be issued to the newly added Opposite Party Nos. 2 & 3 by Speed Post with AD. Postal requisites be filed by tomorrow, fixing a short returnable date. Consolidated copy of the cause title be filed within five working days. Copy of the amended cause title be served upon learned AGA appearing for the State and scanned copy thereof be updated in the Court brief. Apart from taking notice by speed post with AD, learned counsel appearing for the Petitioner is permitted to take by Dasti. Requisites for issuance of notice by Dasti be completed by tomorrow.

List this matter along with W.P.(C) No.20007 of 2025 and W.P.(C) No.20149 of 2025 on 25th August, 2025 under the heading "Fresh Admission".
