- 4.** 1. This matter is taken up through Hybrid Arrangement (Virtual/Physical) Mode.
- 2.** Heard learned counsel appearing for the parties.
- 3.** Learned Sr. Counsel appearing for the Petitioner contended that Petitioner while continuing as Welder Trade Helper, was not allowed change of trade to get the benefit of promotion, on the ground that promotional avenue is there for such Welder Trade Helper. But it is contended that similarly situated Fitter Trade Helper with having promotional avenues, were extended with the benefit of promotion with change of Trade. Stand taken in Para-4 of the rejoinder affidavit reads as follows”

4. That, the following Fitter Trade Helper constables have been allowed to change their trade and given promotion to AS of different trades:

Promotion of ASI

Helper Constable

Hence the action of the Opposite Parties in not allowing the petitioner to change the Trade is complete in violation of the fundamental rights guaranteed under Article 14 & 16 of the Constitution of India.

3.1. It is accordingly contended that Petitioner is entitled to get similar benefit.

4. Learned Addl. Govt. Advocate is directed to file an affidavit as to whether there was promotional avenue for Fitter Trader Helper and on the face of such avenue, they were allowed to change of trade.

5. As requested by the learned Addl. Govt. Advocate, list this matter on 11th September, 2025.
