1. This CRLMP has been filed for a direction to the Opposite Parties No.2 and 3 to register FIR on the basis of complaint of the Petitioner and conduct fair, prompt and effective investigation and rescue the minor daughter of the Petitioner.
2. Instructions dated 20.06.2026 of the IIC, Dhamnagar P.S. has been received where it is stated that on 07.05.2026 a photostat copy of written report was received in the Police Station for which the IIC, contacted the informant over Mobile No.9178653188 to produce the original written report along with photo graphs and aadhar card of victim. But the Petitioner has not appeared at the Police Station nor co-operated. It is also stated that on 18.06.2025 on the written report of wife of the Petitioner, Dhamnagar P.S. Case No. 225 dated 18.06.2025



under Section 137 (2) of the BNS has been registered and the case turned to under Sections 137 (2)/ 64(1)/ 64(2) (m) of the BNS and Section 6 of the POCSO Act and after completion of investigation, charge sheet dated 10.10.2025 under Sections 137 (2)/ 64(1)/ 64(2) (m) of the BNS and Section 6 of the POCSO Act has been submitted against one CICL “R.J.” and under Sections 137 (2)/ 64(1)/ 64(2) (m)/49 of the BNS/ 6 and 17 of the POCSO Act against the CICL “R.M.” (names withheld). It is also stated that the victim is a major. Her date of birth as per her School Admission records is 26.08.2008.

3. Ms. Swadha Rath, learned counsel for the Petitioner submits that before the instructions were received from the IIC, Dhamnagar P.S., the Petitioner had already informed that the IIC, Dhamnagar P.S. had not contacted him over his Mobile Phone No.9178653188 for producing original written report along with photo graphs and aadhar card of victims. She also submits that as per the Anganwadi records, the victim is a minor.

4. In view of such submission of the learned counsel for the Petitioner, list this matter on 25.06.25026 to enable the IIC, Dhamnagar P.S. to file an affidavit giving details on which date he had called up the Petitioner on his Mobile No.9178653188 to produce original written report along with photo graphs and aadhar card of victims along with



the document to show that the victim was a major on 05.05.2026.

5. Copy of the affidavit shall be served on the learned counsel for the Petitioner.
