1. This matter is taken up through Hybrid Arrangement (Virtual/Physical Mode).



2. It is submitted by Mr.D.P.Dhal, learned Senior counsel appearing for some the appellants that in the Cause Title of the order dated 22.09.2025 of this Court, the names of the appellants in some of the Criminal Appeals have been inadvertently wrongly typed instead of their correct names.

3. Considering the aforesaid submission and finding the mistake in typing out the name of some of the appellants in the cause title of the order-sheet dated 22.09.2025, the names of appellant be correctly reflected against the CRLA Nos. in the following manner **Aniket Mishra (In CRLA No.584 of 2025); Subham Sharma (In CRLA No.596 of 2025); Varun Bhati @ Barun Bhati (In CRLA No.597 of 2025) and Siddhant Sharma (In CRLA No.801 of 2025).** The aforesaid correction be carried out forthwith by Mr. Jayakrushna Dash who has typed out the aforesaid order.

6. On the request of Mr. S.K.Jena and Mr.D.R.Parida, learned counsel for the informant and the injured, a copy of the objection filed by the State and the affidavit filed by rest of the appellants except the appellant, Akash Poddar be supplied to them.

7. Further, the appellant in CRLA No.1075 of 2025 is hereby requested to collect all the objections and affidavit from the concerned Counsel.

8. Learned State Counsel is further requested to obtain the up-to-date Case Diary including the statements of the witnesses recorded in this case by next date.
