01. This matter is taken up through Hybrid arrangement (video conferencing/physical mode).

Heard Mr. Prajit Kumar Pradhan, learned counsel for the petitioner, Mr. Satya Sindhu Kashyap, learned Central Government Counsel appearing for the opposite parties nos.1 to 3 and Mr. Arupananda Das, learned Additional Government Advocate appearing for the opposite party no.4.

The petitioner Biranchi Garnaik has filed this writ petition with a prayer to direct the opposite parties to pay



the compensation amount against the rabi crop for the year 2020-21 and 2021-22 and against kharif crop for the year 2021-22 for the land situated at Mouza- Bhalupal and compensation amount against rabi crop for the year 2020-21 and 2021-22 for the land situated at Tungamal village with a further prayer to direct the opposite parties to pay the compensation amount towards both kharif and rabi crop for the year 2022-23 and 2023-24 in respect of land situated at both the village Bhalupal and Tungamal and also with a further prayer to direct to pay the compensation towards excess land so acquired in respect of plot no.101 and 102, Khata No.5 of Mouza- Bhalupal.

Referring to the information sheets, which are annexed to the writ petition as Annexure-4 series and Annexure-6, learned counsel for the petitioner submits that the petitioner has not received the compensation amount as prayed for in the writ petition and the authority has also not returned the land in the original condition till 15.04.2024 even though they were supposed to do the same by 2022.

Issue notice on the question of admission indicating therein that the matter shall be disposed of finally at the stage of admission.

Learned Central Government Counsel for the Union of India accepts notice on behalf of opposite parties nos.1 to 3. Three extra copies of the writ petition be served on the learned Central Government Counsel by 22.08.2024.

Learned counsel for the State accepts notice on behalf of opposite party no.4. One extra copy of the writ petition be



served on the learned counsel for the State by 22.08.2024.

List this matter in the week commencing from 17.09.2024.

Counter affidavit, if any, be filed in the meantime after serving copies thereof on the learned counsel for the respective parties.
