1. The matter is mentioned at the beginning of the days' Court proceeding and it is submitted by the learned Senior Counsels appearing for the parties that the matter may be taken up.

5. It is submitted by the learned Sr. Advocate, Mr. Mohanty for petitioners that though interim order dated 27.09.2021 was till disposal of the writ application, Co-ordinate Bench by order dated 01.11.2021 observed that interim order will continue till the next date.

Accordingly, a prayer is made for extension of the interim order dated 01.11.2021.

6. The interim order dated 27.09.2021, reiterated on 01.11.2021, shall continue until further orders.
