**2.** Pursuant to order dated 02.07.2026, the Contemnor is physically present before this Court and submits, though a prospective buyer has been arranged for selling the land to meet the payments to be made with the Petitioners, but



the sale could not be materialized due to the rainy season and failure to demarcate the land.

**3.** However, the Contemnor undertakes to do the needful to make payment by end of August, 2026.

**4.** In view of such undertaking, the matter stands adjourned to be listed on 7<sup>th</sup> September, 2026 along with the connected matters on board.

**5.** The Contemnor is to file compliance affidavit by 31<sup>st</sup> August, 2026. It is made clear that, if the Contemnor fails to file compliance affidavit, he shall remain physically present in this Court on the adjourned date at 10.30 A.M.
