1. This matter is taken up through hybrid mode.
 2. The Petitioner in this writ petition prays for a direction to the Opposite Parties to sanction and disburse the compensation amount in favour of the Petitioner pursuant to order dated 20th September, 2019, passed by learned Civil Judge (Senior Division), Bhawanipatna in LAR No.46 of 2019, initiated under Section 18 of the Land Acquisition Act, 1984 (for brevity, 'the Act').
 3. Mr. Das, learned counsel for the Petitioner submits that being not satisfied with the award passed under Section 11 of the Act, the Petitioner filed an application to refer the matter to the Civil Court for enhancement of the land acquisition compensation. Accordingly, the matter was referred to the Court of learned Civil Judge (Senior Division), Bhawanipatna and was registered as LAR No.46 of 2019. The said reference under Section 18 of the Act was disposed of vide order dated 20th September, 2019 (Annexure-1) enhancing the compensation.



4. Mr. Das, learned counsel for the Petitioner further submits that although the order for enhancement of compensation was passed on 20th September, 2019, the Petitioner has not yet received the compensation in terms of the said order. Thus, finding no other alternative, the Petitioner has filed this writ petition for the aforesaid relief.

5. Taking into consideration the case of the Petitioner, this Court, vide order dated 22nd January, 2026, directed the learned State Counsel to take instruction with regard to the status of disbursal of compensation in favour of the Petitioner in terms of order passed in LAR No.46 of 2019.

6. Mr. Mishra, learned Additional Standing Counsel, on instruction, submits that the Special Land Acquisition Officer, Upper Indravati Irrigation Project, Kusumkhunti in the district of Kalahandi over telephonic message has sought for sanction of the Water Resources Department, Government of Odisha for disbursal of the compensation to the Petitioner in terms of order passed in LAR No.46 of 2019. The same is yet to be received. On receipt of order of sanction, the compensation along with statutory dues shall be paid to the Petitioner forthwith.

7. Taking into consideration the submissions made by the learned counsel for the parties and on perusal of records, this Court finds that the order enhancing the compensation was passed by the learned Civil Judge (Senior Division), Bhawanipatna on 20th September, 2019 in LAR No.46 of 2019. Although six years have already elapsed in the meantime, the compensation in terms of the aforesaid order has not been released in favour of the Petitioner along with the statutory dues.

8. It is submitted by Mr. Mishra, learned Additional Standing Counsel that the sanction is yet to be received from the Administrative Department for disbursal of the compensation along with statutory dues.



9. In view of the above, this Court directs the Additional Chief Secretary, Water Resources Department, Government of Odisha, Bhubaneswar (Opposite Party No.1) to accord sanction for disbursal of the compensation in terms of order dated 20th September, 2019, passed by the learned Civil Judge (Senior Division), Bhawanipatna in LAR No.46 of 2019, as expeditiously as possible, preferably by end of May, 2026 and on receipt of such sanction order, compensation along with statutory dues shall be released in favour of the Petitioner on proper acknowledgement verifying the entitlement, as expeditiously as possible, preferably by end of August, 2026.

10. With the aforesaid observation and direction, the writ petition is disposed of accordingly.
