- 1.** Learned counsel appearing for the petitioner submitted that originally the scheduled property in the status of Sarad-III stood recorded in the name of one Baban Nayak. After certain sale transaction, the petitioner has come to possess the land by way of registered sale deed.
- 2.** Though in the Yadasta (Annexure-8) the name of the vendor is recorded in the Hal Record of Rights, the said land has been recorded as “*Abadajogya Anabadi*” in Government Khata. Therefore, the petitioner approached the Board of Revenue in OSS No.1169 of 2021 invoking Section 15(b) of the Odisha Survey and Settlement Act, 1958, which came to be disposed of by the Additional Commissioner, Additional Revision Court-II, Bhubaneswar, who dismissed the revision petition taking flimsy ground that the petitioner did not furnish certified copy of W.L.L. Case No.2097 of 1973.
- 3.** Learned counsel appearing for the petitioner submitted that in an identical fact situation, this Court in the cases of *Narottam Rath Vs. State of Odisha, Secretary, Department of Revenue and*



*others, 2025 (III) ILR-CUT-859 and Simple Sujata Mishra Vs. State of Odisha and others, 2026(I) OLR 135 [WP(C) No.9777 of 2014, disposed of on 22<sup>nd</sup> October, 2025], granted relief to the petitioner by entertaining the writ petition against the revisional order passed under Section 15(b) of the Odisha Survey and Settlement Act, 1958.*

4. Issue notice to the opposite parties.
5. Mr. Saswat Das, learned Additional Government Advocate appears and waives service of notice on behalf of opposite party nos.1 to 5 and seeks a short accommodation to obtain instruction in this regard.
6. Issue notice to the opposite party nos.6 to 10 by Speed Post with A.D., requisites for which shall be filed within three working days. In the event of furnishing such requisites within the period stipulated, the Office shall send the notice to the said opposite parties by fixing a short returnable date.
7. List this matter in the week commencing 4<sup>th</sup> May, 2026.
