1. The present writ petition has been filed under Articles 226/227 of the Constitution of India seeking issuance of a writ in the nature of mandamus directing the respondents to consider, process and grant the benefit of job security and adjustment to the petitioner against the post of Junior Engineer (Civil) (Group C) in the Development and Panchayat Department/Public Health Engineering Department or any other suitable department, strictly in terms of the Haryana Contractual Employees (Security of Service) Act, 2024, the Human Resources Department Circular dated 03.04.2025 (P-7), the consequential Development and Panchayat Department memorandum dated 04.04.2025 (P-8) and the verified service record of the petitioner forwarded vide letter dated 07.05.2024 (P-5) with continuity of service and all consequential benefits.



2. Reply filed on behalf of respondents No.4 and 5 is taken on record. Copy of the same has been supplied to learned counsel for the petitioner whereas learned State counsel prays for time to file reply on behalf of respondents No.1 to 3, 6 and 7.

3. At this stage, learned counsel for the petitioner states that he would be satisfied in case the respondents consider his claim and decide his representation dated 18.09.2025 (Annexure P-13), which is still pending, by passing speaking order.

4. Learned State counsel assures this Court that the said representation dated 18.09.2025 (Annexure P-13) will be considered and decided, in accordance with law.

5. In view of the above, without adverting to the merits of the case, respondents/competent authority, is directed to decide the **representation dated 18.09.2025 (Annexure P-13)**, in view of judgment passed by this Court in **CWP-7437-2025** titled **Renu & Ors. Vs. State of Haryana & Ors.**, decided on 24.12.2025 (P-18), **CWP-5904-2026** titled **Waseem Akram & Ors. Vs. State of Haryana & Ors.**, decided on 25.02.2026 (P-19) and **CWP-6517-2026** titled **Mohit Gautam & Ors. Vs. State of Haryana & Ors.**, decided on 05.03.2026 (P-20), after providing due opportunity of personal hearing to the petitioner, within a period of 08 weeks from the date of receipt of certified copy of this order. The order so passed shall be furnished to the petitioner within one week thereafter.

5. The petition stands disposed of in the aforesaid terms.
