This order shall dispose of two appeals filed by the appellants/claimants namely **Pawan Kapoor in FAO-1946-2024 and Som Nath and others in FAO-3741-2024** seeking enhancement of the amount awarded by the MACT.

Both the appeals have been entrusted to this Forum for the purpose of settlement.

On 19.03.2026, on behalf of the appellant (s) statement (separately recorded), was made by learned counsel for the appellant(s) to accept Rs.11,00,000/- (Rupees Eleven Lakh only) in FAO-1946-2024 and Rs.8,50,000/- (Rupees Eight Lakh and fifty thousand only) in FAO-3741-2024 more, over and above, the amount awarded by the MACT concerned, in full and final settlement of the claim in these appeals.

Today, on behalf of the Insurance Company concurrence has been given to the effect that total amount of Rs.19,50,000/- would be paid in both these appeals to the appellants-claimants and out of which Rs.14,50,000/- would be paid to the appellant-Pawan Kapoor in FAO-1946-2024 and Rs.5,00,000/- would be paid to appellant No.2-Usha Rani in FAO-3741-2024.

Learned counsel for the appellant (s) on instructions submits that he is ready and willing to accept the aforesaid concurrence and has given a statement to this effect.

As per the statement of the learned counsel for the appellant (s), the enhanced amount i.e. Rs.14,50,000/- would be paid to the appellant-Pawan Kapoor in FAO-1946-2024 and Rs.5,00,000/- would be paid to appellant No.2-Usha Rani in FAO-3741-2024.

We dispose of these cases with a direction to Insurance Company to deposit two crossed-cheques, one in the sum of Rs.14,50,000/- (Rupees Fourteen lakh and fifty thousand only) in the name of the appellant-Pawan Kapoor in FAO-1946-2024 and another in the sum of Rs.5,00,000/- (Rupees Five Lakh only) in the name of appellant No.2-Usha Rani in FAO-3741-2024 with the office of the Lok Adalat of the High Court on or before 11.05.2026 failing which the amount will carry 9% interest p.a. from the date of this order till the cheques are deposited with the office of the Lok Adalat. The appellant (s)'s counsel/appellant (s) may collect the cheques from the office of the Lok Adalat.

All the civil miscellaneous applications stand disposed of in view of settlement in these appeals.

Copy of the order/statement be supplied /sent to the counsel/parties and file be returned to the High Court.

A photocopy of this order be placed on the file of connected case.
