1. The present petition has been filed by the petitioners under Articles 226/227 of the Constitution of India, seeking issuance of a writ of mandamus, directing the respondents to grant the petitioners pay scale and allowances as per Punjab Civil Services (Revised Pay) Rules, 2009 (Annexure P-2) as revised in 2011 (Annexure P-3) i.e. 10300-34800 + 3000 Grade Pay along with all allowances applicable under the 5th Punjab Pay Scale Matrix in view of the judgment passed by this Court in *CWP-15896-2023 titled as 'Saurabh Sharma and others Vs. State of Punjab and another'* decided on 13.09.2024 and other connected cases (Annexure P-6). Further seeking issuance of a writ of certiorari for quashing the conditions mentioned in the appointment letters (Annexure P-4) to the extent it prescribes salary of the petitioners contrary to the Punjab Civil Services (Revised Pay) Rules, 2009.

2. Learned counsel for the petitioners submits that for redressal of their grievances, the petitioners have also served legal notice dated 08.01.2026 (Annexure P-9) to the respondents which is still

pending consideration. He further submits that at this stage, the petitioners would be satisfied, if appropriate directions are issued to the respondents to consider and decide the said legal notice, by passing a speaking order, in a time bound manner.

3. Notice of motion.

4. Mr. Satnampreet Singh Chauhan, D.A.G., Punjab, accepts notice on behalf of the respondents-State. He has no objection to the innocuous prayer made by learned counsel for the petitioners.

5. I have heard learned counsel for the parties and have gone through the record of the case.

6. Without going into the merits of the case at this stage, the present petition is disposed of with a direction to respondent No.3 to consider and decide legal notice dated 08.01.2026 (Annexure P-9) submitted by the petitioners expeditiously, by passing a speaking order after affording an opportunity of hearing to the petitioners, preferably within a period of 03 months from the date of receipt of certified copy of this order. Further, the decision taken thereon shall be conveyed to the petitioners.
