The instant petition has been filed for grant of pre-arrest bail to the petitioner(s) in case bearing FIR No. 379 dated 22.11.2025 for offence(s) under Sections 318(4), 336(3), 338, 340, 61 of the Bharatiya Nyaya Sanhita, 2023 registered at Police Station City Tohana, District Fatehabad.

2. Learned counsel for the petitioner(s) *inter alia* contends that pursuant to the order dated 16.04.2026 passed by this Court, the petitioner(s) has joined investigation and his custodial interrogation is no longer required for investigation of the case.

3. Learned State counsel on instruction from the Investigating Officer, corroborates the said averment and submits that further custodial interrogation of the petitioner is not required for the purpose of investigation.

4. Heard learned counsel for the parties.

5. Since the petitioner(s) has joined the investigation and his custodial interrogation is not required, the present petition is ***allowed*** and the interim order dated 16.04.2026 is made absolute.
